Meeting Minutes

January 4, 2017



Meeting commenced: 6:30pm Loutit Library: Meeting Room A

Presentation by American Atheltix: John McDonald

American Atheltix, based in Muskegon, is a full service playground equipment company. They represent Play and Park, a traditional post and platform playground equipment manufacturer, and Kompan, a child-focused play equipment company. The Friends group has already investigated Play and Park structures.

John McDonald presented the Kompan philosophy and design structures to the Friends group. He shared with us a diagram of a potential Corocord system designed with a nautical theme to fit the nature of Grand Haven State Park. This type of play structure would be unique to the area and would offer a different play experience and would complement existing playground equipment in the Park. We also looked at other offerings from the Kompan catalogs.

The group thanked John for the information, and based on our feedback, he is going to configure and price two structures to fit our needs: one installation appropriate for age 2-5 and a separate installation targeting ages 5-12. A Friends group discussion took place at the end of this meeting.

December meeting minutes were approved.

Becky Newman volunteered to contact Alyssa Buck. The group would like to discuss ideas with Matt Shaver and will put this item on the agenda for the February 13th meeting.

Annual Dues are due! The membership rate remains \$10.00/person.

Playground discussion:

The entire group was in favor of pursuing the Kompan system of play. We agreed with the philosophy that, when designed to really promote child development, playgrounds can significantly improve children's health, learning and social interaction. The unique Kompan Corocord climbing system would be a "destination" playground for the area. Additionally, this type of play fits in with the goals of the Governor's Council on Physical Fitness.

The group remains committed to providing accessible facilities, but have expanded our definition of that to include children with mobility, sensory and social challenges. Given that the Friends group has a budget to work with, it was decided that we would prioritize the acquisition and installation of the playground project in three phases:

Phase One: Pirate Ship with creative play elements for the 2-5 age groups (to include surface tiles)

Phase Two: Corocord climbing system for the 5-12 age groups with Nautical theme

Phase Three: Surfacing

A motion was approved to seek pricing from American Athletix for the acquisition and installation of Phase One and as much of Phase Two as our budget of \$70,000 allows.
