Friends of Grand Haven State Park Meeting Minutes April 10, 2023



Meeting commenced: 3:33pm via Zoom.

Roll Call: Mike Mazurek, Judi Mazurek, Bob Moore, Becky Newman, Dave Brinks, Andy Lundborg, Arica Johnson. Karen Casey could not connect due to internet outage.

Mike welcomed the group, thanked everyone for attending and provided the following summary:

- 1) The check for the Mobi mats project was sent to Andy Lundborg. Andy sent the gift and acceptance form to Lansing and hopes to hear from them this week. He can then order the mats.
- 2) Mike attended Ron Olsen's address at the Friends Summit (virtually) and shared two highlights:
 - a. The Passport revenue is distributed in the following manner: 50% to State Park capital outlay, 30% to maintenance, 10% to local parks, and the rest to forest recreation and State Park cultural & historical funds.
 - b. Three million dollars is set aside for Splash Pads at Warren Dunes, Holland, and Grand Haven State Parks. Andy clarified that this money is proposed in the governor's budget and not yet approved. It includes infrastructure for water safety such as loud speakers, warning lights and signage.

The February meeting minutes were approved.

No Expenses since February: there is an outstanding check for \$13,345 to the State of Michigan for the Mobi mats.

Current cash in the checking account = \$31,211.59.

Water Safety Book: Bob Moore

State Park and City of Grand Haven Meeting: Bob Moore

The Park will open May 1st and is currently closed for sand removal projects.

An initiative by Rivian, the electric car manufacturer, awarded 4 charging stations to Grand Haven State Park. Unfortunately, Grand Haven's Board of Light and Power declined installing them and they have been given to another park.

The Earth Day celebration event is April 29th from 11:00am to 4:00pm at Central Park Place in Grand Haven. The Friends of Grand Haven State Park will have a booth at a cost of \$15.00. Bob Moore and Becky Newman will attend. The following items will be included:

New Business:

The Tri-Cities Family YMCA will be conducting youth programs again this summer at Grand Haven State Park. They have asked the FGHSP and Soccer in the Sand to support their soccer program by providing 4 soccer nets. Soccer in the Sand has committed to providing 2 nets. The nets are estimated to cost \$500 - \$600 each. It was motioned and approved that the FGHSP will donate \$1,000 to the Tri-Cities YMCA for the purpose of acquiring soccer nets.

The group decided to participate in the Kite Festival, weather permitting! Mike and Judi Mazurek will be camping in the park that weekend and Bob Moore and Becky Newman are available.

Andy Lundborg confirmed that we have room to store 8 pallets of wood (6 outside and 2 in the shed). Mike Mazurek will place the order.
