# Friends of Grand Haven State Park Meeting Minutes June 12, 2023



Meeting commenced: 3:40pm at the Pavilion.

Roll Call: Mike Mazurek, Judi Mazurek, Bob Moore, Becky Newman, and Karen Casey.

Mike thanked everyone for their participation in the Kite Festival. We sold 9 t-shirts, 15 bottles of water, added one new member and had \$12.00 in donations. We also had an emergency board meeting to approve an increase in the price of wood bundles from \$6.00 to \$7.00 to cover our cost increase (from \$2.75 to \$3.50).

The Friends Group received a thank you letter from the Tri Cities YMCA for our \$1,000 contribution used to purchase sand soccer nets.

There is no current contract/formal paperwork between the FGHSP and the State of Michigan DNR for either the vending program or our partnership agreement. The last vending contract was signed in 2015 and the last partnership agreement in 2013. Mike is meeting virtually with State of Michigan representatives to discuss the new vending agreement on Thursday, June 15<sup>th</sup> at 12:30pm. Beck Newman volunteered to join the discussion if appropriate.

The May meeting minutes were approved.

# **Treasurers Report: Judi Mazurek**

Deposit since May: \$1,110.70. \$10.62 from Amazon Smile, \$636.00 from wood sales, \$245.00 from fire pit sales, and the rest from Earth Day Celebration and Kite Festival sales.

Expenses since May: \$1,850.00 for West Michigan Beach Volleyball clinics.

Current cash in the checking account = \$14,549.49

We have \$5.00 in savings.

Our insurance provider sent us an advisory that the language of our policy has been changed to reflect that we will not be covered for sexual misconduct situations. Our policy with West Bend will renew in July. Mike contacted Ippel Insurance for a quote, and they recommended we stay with West Bend Insurance.
